M.R.032033 - In re: Fredrick D. Goings. Disciplinary Commission.

Petition by respondent Fredrick D. Goings for leave to file exceptions to the report and recommendation of the Review Board. Denied. Respondent Fredrick D. Goings is disbarred, as recommended by the Review Board.

M.R.032220 In re: Jinhee Kim Wilde. Disciplinary Commission.

Motion by respondent Jinhee Kim Wilde for a hearing on the Administrator's petition to impose reciprocal discipline. Allowed. This matter is referred to the Hearing Board of the Attorney Registration and Disciplinary Commission for a hearing pursuant to Supreme Court Rule 763.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Bruce Elwyn Gardner, who has been disciplined in the District of Columbia, is suspended from the practice of law in the State of Illinois until he is reinstated to the practice of law in the District of Columbia.

Accordingly, no decision will be rendered.

M.R.032333 - In re: Jeffery Mark Leving. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Jeffery Mark Leving is suspended from the practice of law for five (5) months, with the suspension stayed after sixty (60) days by a two (2) year period of probation, subject to the following conditions to commence upon the effective date of this Court's order:

- a. Respondent shall successfully complete the ARDC Professionalism Seminar within 180 days of the execution of the affidavit;
- b. Respondent shall comply with the provisions of Article VII of the Illinois Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct and will timely cooperate with the Administrator in providing information regarding any investigations relating to his conduct;
- c. Respondent shall reimburse the Commission for the costs of this proceeding as defined in Supreme Court Rule 773, and, at least thirty (30) days prior to the termination of the period of probation respondent shall reimburse the Commission for any further costs incurred during the period of probation.
- d. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct;
- e. Respondent shall attend meetings scheduled by the Commission probation officer. Respondent shall submit quarterly written reports to the Commission probation officer concerning the status of his practice of law and the nature and extent of his compliance with the conditions of his supervision;

- f. Respondent shall notify the Administrator within seven (7) days of any arrest or charge alleging his violation of any criminal or quasi-criminal statute or ordinance;
- g. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The suspension shall commence from the date of the determination that any of the terms of the probation have been violated, and shall continue until the remaining term of suspension has been served; and
- h. Probation shall terminate without further order of the Court provided respondent complies with the above conditions.

Suspension effective October 11, 2024.
