Re: Conservation Citation and Complaint Form

Dear Ms. Grant:

Effective January 1, 2025, Public Act 103-0789 requires that all Illinois Citation and Complaint Forms include an admonishment that a defendant's failure to appear in court may lead to significant consequences impacting the violator's driving privileges.

In compliance with these new requirements under 625 ILCS 5/6-308, the Illinois Uniform Citation and Complaint Form has been updated accordingly by modifying the Notice to Appear language on the Violator copy of the citation form as follows:

NOTICE TO APPEAR

The results of your failure to appear or pay this ticket is based on whether your ticket is marked "Court Appearance Required" or "No Court Appearance Required" and may result in either a judgment of conviction being entered against you for fine penalties, assessment, and cost as provided in the NOTICE OF CONSENT FOR ENTRY OF JUDGMENT; or, the court may order a warrant to be issued, other significant consequences affecting your driving privileges, or you may be tried and sentenced in your absence.

Effective January 1, 2025, all agencies must update their electronic citation programs to comply with the new standards. Agencies using paper citation forms may continue to use their existing stock approved on September 1, 2023, provided they apply a sticker over the "Notice to Appear" admonishments on the Violator copy until updated forms with the required revisions are ordered.

In addition, clarifying language has been added to the Notices of Consent for entry of Judgment.

There have been no changes to the Printing Instructions. The Conference of Chief Circuit Judges (Conference) approved these amendments on December 6, 2024. On behalf of the Conference, I hereby submit the amended Conservation Citation and Complaint Form, effective immediately.
