To the Honorable Chief Justice and Justices of the Supreme Court:

I tender herewith the report of my administration as Director of the Courts of the State for the calendar year 1968, together with the statistical reports for all courts of the state.

I became Director on January 1, 1968, after resigning my position as Circuit Judge of the Second Judicial Circuit. This is the first report I have made to you. I am sorry that it is being published later in the year than previous reports but the duties you assigned me in connection with the 1969 legislative session prevented me from preparing it until after the adjournment of the legislature on June 30th.

I have not repeated the historical information contained in the 1964, 1965, 1966 and 1967 reports since I feel that the 1964 Judicial Article has been substantially implemented and is beyond its formative period. This is a factual report of how the Judicial System in Illinois operated in 1968.

# To the Honorable Chief Justice and Justices of the Supreme Court of Illinois:

This report is addressed to you as a record of various judicial developments, some resulting from legislative enactments, changes in our judicial personnel, and as an account of the activities of the Administrative Office. Most of these matters have been reported to you in my administrative conference with you held during each term of court. This report will provide a permanent record of the operation of the court system in Illinois during the year 1968.

It will be distributed to all judges, clerks, legislators, state officials in Illinois, and to lawyers who request it. It will be sent to all Court Administrators in the nation and to all the law schools and to any other interested individuals.

This report will cover the activities of the courts, list the state's judicial personnel and give the statistical data on all courts during the year, and will in addition record the following significant developments:

#### SIGNIFICANT COURT LEGISLATION IN 1968

Although 1968 was not a regular legislative year, the 75th General Assembly reconvened in March and July and enacted into law several statutes and amendments to statutes.

Article 4, Section 13, of the Constitution provides that "no act of the general assembly shall take effect until the first day of July next after its passage, unless in case of emergency, (which emergency shall be expressed in the preamble or body of the act), the general assembly shall, by a vote of two-thirds of all the members elected to each house, otherwise direct."

An act passed by the General Assembly prior to July 1st but not approved by the Governor until subsequent thereto becomes effective on date of approval by the Governor.

A number of bills passed at the July 1968 session were passed without emergency clauses. Such bills became law upon their approval but did not become effective until July 1, 1969. The bills that contained an emergency clause became effective on the date of approval or at such later date as was expressed in the emergency clause.

One statute passed by the 1968 session in July which contained an emergency clause and became effective when signed by the Governor on July 26, 1968, amended Sec. 72.2 of Chapter 37 by reducing the population requirement for electing a fourth circuit judge from 280,000 to 270,000 and further providing for election of a fourth circuit judge in circuits of at least 230,000 which contained one county of more than 200,000 population.

This legislation resulted in the election in 1968 of fourth circuit judges in the 3rd, 14th, 16th, and 17th Circuits. Elected in the 3rd Circuit was William L. Beatty; in the 14th Circuit, Charles J. Smith (formerly an Associate Judge); in the 16th Circuit, John S. Page (formerly an Associate Judge); and in the 17th Circuit, Seely P. Forbes (formerly an Associate Judge).

#### THE JUDICIARY—RETIREMENTS AND CHANGES

At the November 1968 General Election, several judges were elected to replace those judges who had passed away or resigned since the 1966 general election.

At the same November election, several judges stood for retention as permitted under the new Article. All the judges running for retention were returned to office.

During 1968 the following deaths occurred in the judiciary in Illinois, with the date of death being shown in parentheses:

Circuit Judge Cornelius J. Harrington of Chicago, (7/7/68), and Associate Judges Irwin C. Taylor of Kankakee (4/15/68), Harry L. Pate of Tuscola (4/20/68), Austin A. Lewis of Madison (5/28/68), Winthrop B. Anderson of Pittsfield (10/5/68), John M. Karns of Belleville (11/8/68); and James L. Sparing (5/2/68), John J. Sullivan (6/7/68), Irving Goldstein (7/11/68), all of Chicago. In addition to the deaths of these distinguished jurists, our ranks were further depleted by the deaths of Supreme Court Clerk, Mrs. Earle Benjamin Searcy, (3/24/68), and Fifth District Appellate Court Clerk, James R. McLaughlin (12/18/68). Deputy Supreme Court Clerk Clell Woods was appointed Clerk Pro Tem by the Supreme Court and served until Justin Taft, who was elected in the November election, took office in December. Walter T. Simmons was appointed Clerk Pro Tem of the Fifth District Appellate Court to serve until a successor is elected in the November 1970 election.

#### THE JUDICIARY—ACTIVITIES The Supreme Court

As set out in the statistical tables and charts which appear on pages ... to ... immediately after this formal report, the Supreme Court during 1968 consisted of the same seven justices who served in 1967, with the Honorable Roy J. Solfisburg, Jr. continuing as Chief Justice during the entire year.

In 1968 the Supreme Court decided 263 cases with full opinions, an increase of 18 over 1967, disposed of 76 petitions for rehearing, 303 petitions for leave to appeal and 847 motions of various other types.

In addition to its heavy case load, the court was involved in other court responsibilities and duties.

The Chief Justice, under the Constitution, is charged with the administration of all courts in Illinois, and supervises the work of the Director and staff of the Administrative Office.

Justice House carried the burden of the fiscal and budgetary responsibilities which he handles on behalf of the Court. Justice House worked with the Director of the Administrative Office in close supervision of the Accounting Division which handles all salaries, expense accounts and matters of similar nature. He also worked with the Director on the preparation of the annual budget for the Court after conferences with other members of the Court.

Justice Underwood served as liaison officer from the Supreme Court to the Executive Committee of the Judicial Conference and to the Conference of Chief Circuit Judges. Through his work with the Executive Committee, Justice Underwood guides the course of its planning for possible substantive and other changes in the administration of justice and has supervision over the various seminars and other activities conducted by the Judicial Conference. Justices Schaefer, Kluczynski, Ward and Klingbiel, in addition to the other members of the Court mentioned above, carried out the burden of disposing of motions of emergency nature presented to them in their respective districts and spent much of their valuable time delivering addresses before law schools, bar associations, and other civic groups in Cook County and other parts of the state.

#### The Appellate Court

Immediately following the statistical section which relates to the Supreme Court appears a listing of all members of the Appellate Court and charts showing the trend of cases, the number of cases disposed of, the time elapsing before opinion in each of the several districts.

The Appellate Court of Illinois is organized in the same five districts from which the Supreme Court is elected. The First District, made up of Cook County, has approximately 52% of the population of the state. Just as the First District has three of the seven justices of the Supreme Court, that district has twelve of the twenty-four judges of the Appellate Court. The twelve judges in the First District are divided into four equal divisions. Each of the other four districts has three elected judges resident in that district. In addition to the duly elected Appellate Judges, during 1968 the Supreme Court saw fit to assign a circuit judge to sit as an Appellate Court Judge in the Second District. Circuit Judge Glenn Seidenfeld of Waukegan was assigned to sit as an appellate judge in the Second District and was used in conjunction with the other three judges to distribute part of their workload.

In the First District, circuit judges Thaddeus V. Adesko and Daniel J. McNamara were assigned to duty in the Appellate Court to fill the vacancies caused by the elevation of the Honorable Thomas E. Kluczynski to the Supreme Court and the resignation of the Honorable James R. Bryant. After these vacancies were filled in the November 1968 election, Circuit Judge Daniel J. McNamara was assigned by the Supreme Court to duty in the First District Appellate Court as a thirteenth judge to help with the workload in the district.

In the Third District, following the untimely death of Judge Coryn, Circuit Judges John T. Culbertson, Jr. and August J. Scheineman were assigned temporarily by the Supreme Court to sit with the remaining Appellate Judges and served with them until Judge Howard C. Ryan was elected to the Appellate Court in November.

During the year the judges from the 2nd, 3rd, 4th, and 5th Districts were assigned to the First District to assist them with their workload. The 2nd District judges went one time and heard oral arguments and wrote opinions in sixteen cases. The 3rd, 4th, and 5th District judges each went two times and took an average of twelve cases each trip.

#### The Circuit Courts

The most significant development during the year was the increased number of assignments of judges which were made from one circuit to another by the Administrative Director acting for the Chief Justice. 75 downstate circuit and associate judges were assigned for a total of 256 weeks and 4 days (1284 days) to Cook County. In addition, 44 downstate magistrates were assigned to Cook County for 116 weeks and 4 days (584 days). In the 20 circuits outside of Cook County, 36 judges served for a total of 82 weeks in a circuit other than their home area. One retired judge was recalled to service for 22 weeks during the year.

This represents a total of 11 years and 11 months of normal judicial service which was gained by the use of the Chief Justice's assignment authority. It increased the usable manpower by about 12 judicial positions.

The statistical tables contained herein demonstrate that the business of the trial courts in the state was being handled in satisfactory fashion in all circuits with the exception of the Law Jury Division of the Circuit Court of Cook County. Here we are still plagued with delay in the trial of negligence cases where the ad damnum is more than \$10,000.00. Many factors have contributed to cause this situation and it remains a difficult problem to solve. Hopefully some improvements can be made in the near future which will help to alleviate the problem.

It was demonstrated again this year that the drafters of the 1962 Judicial Article made a mistake when they made no provisions for the filling of vacancies until the next general election after they occur. Many of the vacancies which were filled in November had existed for varying numbers of months up to almost two years. The shortage of manpower which results when a vacancy exists is especially critical in Cook County which has half of the state's population and almost half of the judicial positions. The 1967 legislation which provided for the filling of vacancies by appointment by the Governor until the next general election was invalidated by the Supreme Court by reason of the language in Section 10 of Article VI of the Constitution which says: "Provided, however, the General Assembly may provide by law for the selection and tenure of all judges provided herein as distinguished from nomination and election by the electors, but no law establishing a method of selecting judges and providing their tenure shall be adopted or amended except by a vote of two-thirds of the members elected to each house, nor shall any method of selecting judges and providing their tenure become law until the question of the method of selection be first submitted to the electors at the next general election."

#### THE COURTS COMMISSION AND ITS ACTIVITIES

The Illinois Courts Commission was created by Section 18 of Article VI which became effective on January 1, 1964, Critics of the new Judicial Article have contended that the Courts Commission has been an ineffective and inactive body. Nothing could be farther from the truth.

The Courts Commission was appointed in the spring of 1964. On May 18, 1964, the Supreme Court adopted Rule 59.2 setting forth the procedure to be followed in connection with disciplinary or disability complaints against judges. This is now Rule 51 of the Supreme Court. A joint committee of the Chicago Bar Association and the Illinois State Bar Association has met regularly during 1968 in an effort to suggest amendments to Rule 51 which will make the Courts Commission even more effective. Presently the Commission is not convened except on order of the Supreme Court or at the request of the Senate. This is a somewhat cumbersome method and the joint committee will recommend that the Courts Commission be a continuing body permanently convened to consider all questions of misconduct or disability of judicial officers. (Rule 51 was so amended in June 1969 following the recommendation of the joint committee.)

This report of the activities of the Courts Commission has been prepared from the records and files in the Administrative Office. In 1964 and 1965, during the first months of operation of the new Judicial Article, 92 investigations were made by the Administrative Director as Secretary of the Commission as a result of written complaints or upon his own initiative. Results of the investigations were reported to the Supreme Court. No formal complaint seeking the removal of a judge was filed before the Commission in 1964 or 1965.

In 1966, 101 complaints were investigated by the Administrative Director concerning either the misconduct or disability of judicial personnel. 31 of these complaints were of sufficient validity to cause an intensive investigation to be made of the charges, and reports of same made to the Supreme Court. Three of the complaints were of serious enough nature that machinery was set in force to cause a formal complaint for removel to be prepared but in each instance, the judge voluntarily resigned and this made further proceedings unnecessary. In addition to these three situations, during 1966 in two other cases, corrective measures were taken to make certain that the judges' mistakes were not repeated.

In 1967, 107 complaints were initiated. All of these were investigated and 23 of them were deemed sufficiently important for an extensive investigative report to be made to the Supreme Court. Formal complaints seeking removal were filed during 1967 against two judicial officers. One of them resigned before the public hearings and made further proceedings unnecessary. The other formal complaint resulted in a complete public hearing being held before the Commission in early 1968 and in that instance, the Commission did not order removal of the judicial officers involved.

In four instances where a public hearing by the Commission might have been warranted, the judges voluntarily left the bench. In two other cases, reprimands were given by the Court.

During the entire period from January 1, 1964 to December 31, 1967, nine resignations of judicial officers were brought about either by actual Commission action or by the threat of Commission action.

After I became Director of the Administrative Office on January 1, 1968 and Secretary of the Illinois Courts Commission, and until June 30, 1969 when Supreme Court Rule 51 was amended to create a continuing Commission, I processed complaints from 227 citizens who were complaining about the conduct or the disability of judicial officers. In addition to the actual complaints, some investigations were conducted on my own initiative. The extent of the investigations depended upon the seriousness and the validity of the charges made. 21 of the investigations warranted a full report being made to the Illinois Supreme Court during administrative conferences with them and, during this period of time, seven resignations of judicial officers in Illinois were made as a result of the existence of the Illinois Courts Commission. I am prepared to say that during this period of time when I was charged with the duty of being Secretary of the Illinois Courts Commission, there is no question but that the existence of the power of convening the Illinois Courts Commission was a very effective tool in the administration of justice.

#### THE JUDICIAL CONFERENCE AND SCHOOLS

The year 1968 was a busy and eventful year for the Illinois Judicial Conference. Three major projects of the conference included seminars for judges, magistrates and newly elected judges.

The Second Magistrate Seminar of the Illinois Judicial Conference was held at the Center for Continuing Education from February 28 through March 1, 1968. The Seminar was planned under the direction of the Magistrate Seminar Coordinating Committee and was chaired by Circuit Judge Gale A. Mathers.

Group discussions were conducted on five topics:

- 1. Administration of Estates
- 2. Post-Trial Procedures in Civil & Criminal Cases
- 3. Discovery in Civil & Criminal Cases
- 4. Magistrates in Illinois
- 5. Juveniles and the Court

Panel discussions were held on two topics:

- 1. The New Supreme Court "Traffic" Rule
- 2. Search Warrants and Preliminary Hearings

In addition, the Seminar was addressed by Chief Justice Roy J. Solfisburg, Jr. and Administrative Director Roy O. Gulley. Total attendance at the Seminar was 219.

The 1968 Judge Seminar of the Conference was held at the Center for Continuing Education on September 4, 5 and 6 under the chairmanship of Justice Mel Abrahamson of the Illinois Appellate Court. The Conference was addressed by Chief Justice Roy J. Solfisburg and Justice Robert C. Underwood of the Illinois Supreme Court and Administrative Director Roy O. Gulley. In addition, The Honorable Thurgood Marshall, Associate Justice, United States Supreme Court, was a guest and main speaker of the Conference.

Group discussions were conducted on the following topics:

- 1. New Developments in Criminal Law;
- 2. Post-Conviction Hearings;
- 3. Mental Cruelty as Grounds for Divorce;
- 4. Problems of Product Liability.

Lectures on selected evidence topics and a panel discussion on the pattern jury instructions for criminal cases (IPI-Criminal) completed the program. Total attendance at the Seminar was 340.

The first Seminar for New Judges (elected to office in November, 1968) was held on December 10, 11 and 12 at the Lake Shore Club of Chicago. The Seminar was chaired by Justice Charles H. Davis of the Illinois Appellate Court who also served as chairman of the planning committee for the Seminar.

The newly elected judges were addressed by Chief Justice Roy J. Solisburg, Jr. and Justice Walter V. Schaefer of the Illinois Supreme Court. Lectures on the following topics were presented:

1. The Illinois Judicial System—its Structure and Operation

- 2. Selected Topics of Evidence
- 3. Illinois Pattern Jury Instruction-Civil

Seminar and discussion programs were conducted on the following topics:

- 1. The Trial and the Judge's Authority;
- Criminal Law With Federal Overtones—
   a. *Miranda* and its Implications;
  - b. Other New Developments;
- 3. Pre-Trial Procedures in Criminal Cases;
- 4. Post-Trial Procedures in Criminal Cases.

A question and answer session completed the seminar program. Attendance at the seminar was 32 circuit and associate judges.

In addition to the Seminar activities of the Conference, three standing committees were appointed by the Executive Committee to study particularly difficult problem areas of the law and judicial administration. They are:

- 1. The Committee on the Status of Magistrates
- 2. The Committee on Probation in Illinois
- 3. The Committee on Juvenile Problems.

These committees will conduct their studies and report to the Executive Committee. It is anticipated that these reports may become the subject matter of further seminars or future action by the entire Conference.

#### CONFERENCE OF CHIEF CIRCUIT JUDGES

In accordance with a resolution adopted at its meeting in September of 1967, the Conference of Chief Circuit Judges met quarterly during 1968.

The Conference meetings offer an opportunity for an informal exchange of ideas and helps the Administrative Director to keep abreast of administrative problems in each of the circuits. It would be desirable if the Conference of the Chief Circuit Judges would meet more frequently than quarterly in order that such administrative liaison be kept at an optimum level.

On January 1, 1968, Article V of the Rules of the Supreme Court became effective. Article V was adopted pursuant to the recommendations of the Conference of Chief Circuit Judges and the adoption of those Rules represents the fulfillment of a long program of hearings, drafting and deliberation by the Chief Judges. The Rules were prepared for consideration by the Conference of Chief Circuit Judges by its committee on traffic rules, chaired by Chief Judge John T. Reardon.

There are many innovations in the new rules. Briefly the following represent the significant changes over the former special rules of the Supreme Court:

1. The Supreme Court Rules are now truly uni-

form, applying to Cook County as well as to the 1st and 2nd Class Counties,

2. The Rules are now an integral part of the Supreme Court Rules, being numbered Rules 501 through 556, and constituting Article V of the Rules, rather than being an unnumbered "special" rule.

3. Except for what appears to be an inadvertent reference in the first paragraph of the Order adopting the Rules, the word "quasi-criminal" has been abolished from the rules. The retreat from the use of this comfortable, hazy term will eventually necessitate further refinement of the legislative and judicial thinking about when and to what extent the procedural protections available to defendants prosecuted for "criminal offenses" are to be available to persons charged with what were formerly called "quasi-criminal" offenses.

4. The terms "Traffic Offense" and "Conservation Offense" are defined in Rule 501. While statutes and cases have long referred to "traffic cases", etc. the term has never before been defined by law or by rule.

5. Violations of statutes, ordinances and regulations relating to Fishing, Hunting, Trapping, Boating, Forests and Parks are, for the first time, expressly covered by rules pre-setting bail and establishing procedures similar to procedures applicable to traffic cases.

6. The Supreme Court has overruled its "appearance date" policy which had been established in the old rule. Paragraph E of the old rule provided:

It shall not be necessary for the arresting officer to appear on the day fixed for the defendant to appear and plead.

On the contrary, Rule 504 now provides, in pertinent part, as follows:

It is the policy of this Court that an accused who appears and pleads 'not guilty' to an alleged traffic or conservation offense, should be granted a trial on the merits on the appearance date set by the arresting officer.

With the exception of State Troopers, arresting officers must appear and be prepared to testify on the date they set for a defendant's first appearance in court or face the probability that their case will be dismissed for want of prosecution. Under Rule 505 State Troopers must issue notices informing violators to advise the clerk if they intend to plead "not guilty." This procedure, it is hoped, will foreclose most double appearances by defendants cited by State Troopers.

7. By reason of SB 1168, approved August 14, 1967, the 10% cash deposit provisions of the Code of Criminal Procedure are not now applicable to

offenses punishable by fine only. Thus, bail for overweight violations are once more "in an amount equal to the amount of the fine fixed by statute, plus costs."

SB 1168 also enabled the Court to provide that for certain violations (Driving While Under the Influence, Drag Racing, Reckless Driving and Leaving the Scene of an Accident in which Death or Personal Injury occurred) a valid Illinois drivers license must be deposited *in addition* to 10% of the full cash bail fixed by the Rules. Rule 526(d) so provides. If a defendant cannot deposit a valid Illinois driver's license in those cases, he must post the full cash amount of bail specified by the Rules.

8. Mandatory court appearances for numerous violations previously specified by the Rules have been substantially reduced. However, appearances are now required in the following cases, regardless of the nature of the particular offense:

a. If death or personal injury has resulted.

b. Alleged U.A.R.T. offenses occuring within one year following any other U.A.R.T. offense conviction.

9. Violators who deposit their driver's license in lieu of bail may find their driving privilege indefinitely suspended, if they ignore a traffic ticket. House Bill 620 compliments the longstanding privilege of depositing a license in lieu of bail by providing a serious sanction against those who would abuse the privilege.

#### THE ADMINISTRATIVE OFFICE

The formal duties of the office are those outlined by the State Constitution, by legislative enactments and by rules or administrative orders of the Supreme Court. The informal duties include a carry-over of correspondence relating to the court functions and problems, the gathering and compilation of statistics, the secretarial service for various Supreme Court and Judicial Conference committees, and other duties which are assigned to it by the Chief Justice. In addition, as developed by custom over the years, public relations, legislative liaison and special projects and services have been added to the responsibilities of the office.

A portion of the work of the office, as it relates to various formal and informal duties not previously referred to herein, may be summarized:

#### (a) Court Reporters.

Effective February 1, 1968, the Director adopted and the Supreme Court approved a revised pay schedule for official court reporters.

The salary provisions for court reporters in the original Court Reporter Act were inequitable in many cases and were intolerable from an administrative point of view. Court reporters doing almost precisely the same amount and quality of work were receiving widely divergent salaries (\$6,000 vs. \$9,000 per year) simply because some of them were able to perform slightly better on our proficiency examination.

In some other cases, reporters who have passed our Class A test are being paid \$9,000 per year salary even though they are regularly assigned to very small counties. Others, who came very close to passing our test but have not yet been able to do so (but whose competence has never been questioned) were making only \$6,000 per year, even though they have served well and faithfully for many years, are assigned to counties having 140,000 or more persons and regularly reported a wide variety of cases on heavy trial calls. The new pay schedule was authorized by a 1967 amendment to the Court Reporter Act, (H.B. 1786 approved August 26, 1967) and results in a salary plan in which full time official court reporters are paid amounts ranging from a low of \$6,000 per year to a high of \$9,000 per year on a sliding scale in which factors such as (1) proficiency, as determined by examination, (2) population of the area to which the reporter is normally assigned, (3) experience, and (4) the type of work to which the reporter is normally assigned are taken into consideration in determining a specific salary level.

The 1967 legislation also anticipated a solution to what has always been a very thorny problem. Some "secretaries" were frozen in under the original Court Reporter Act at \$9,000 per year, simply because they had been on the state payroll as official court reporters for more than 5 years as of January 1, 1966. Their positions were quirks of history and most did not even realize that they were classified as court reporters for payroll purposes. The provisions of the 1967 law isolate the problem:

"(d) A court reporter who has been credited with an "A" proficiency rating, without examination, as proveded in Section 7 of this Act, shall continue to receive a salary of \$9,000 per annum. Any increase in the maximum salary payable to reporters shall not result in any increase for such reporters unless and until he has passed Part A of the proficiency test."

Therefore, while the salaries of "grandfathered" reporters will not be reduced an employee will have to demonstrate that he is a fully qualified court reporter by passing our examination before he receives any increases in salary, if any increases are granted in the future.

During 1968, the Administrative Office administered 187 examinations to 176 candidates for certificates of proficiency pursuant to the *Court Reporter Act*.

There were 11 testing sessions conducted at Chicago and Normal. Eighty-seven candidates qualified for a Class A certificate of proficiency. Thirteen reporters passed Part B and 4 passed Part C of our examination. Thirty-six of the 87 reporters who qualified for a Class A certificate of proficiency by passing our examination were official reporters who had been grandfathered in as Class A reporters when the Court Reporter Act was adopted in 1965. These 36 reporters volunteered to take a test to establish their proficiency by examination, even though they were not required to do so, and demonstrated again that even the most vexing administrative problems in our court system can be approached in the spirit of cooperation and good will.

#### (b) Circuit Court Recordkeeping

In 1967 a tentative draft of a proposed administrative order on recordkeeping was widely distributed by our office to lawyers, clerks, accountants and judges. Recommendations and suggestions were collected and incorporated into the Committee's final draft proposal. The Conference of Chief Circuit Judges appointed a committee which revised the statistical reporting system in order to make it consistent with the recordkeeping plan prepared by the recordkeeping Committee. The Committee on Recordkeeping in the Circuit Courts submitted its final comprehensive plan for a uniform system of keeping records of cases, financial records and statistical records to the Supreme Court in 1968.

On May 20, 1968, the Supreme Court adopted The Administrative Order on Recordkeeping in the Circuit Courts of Illinois and on October 1, 1968, the Clerk of the Circuit Court of Logan County at Lincoln, Illinois was directed to begin keeping current court records in accordance with the court's Administrative Order. Since that time, plans have been made to install the uniform system in Jefferson County at Mt. Vernon, Illinois, and, in due course, to expand the system into counties of varying size within each of the four downstate Appellate Districts. It is anticipated that when the experimental counties are completely changed over to the new system, they will be used as model Circuit Clerk's Offices. Circuit Clerks from surrounding counties will be invited to review the system in operation and be instructed in the installation and operation of the new recordkeeping system in their own county.

#### (c) Fiscal

Expenditures of all money appropriated by the General Assembly to the Supreme Court are supervised by the Administrative Office. An accounting department, under a supervisor of accounts, prepares all payrolls, vouchers, keeps books and handles the details involved with the expenditure of funds. By direction of the Court, the Director submits budgetary requirements for both the Administrative Office, Judicial Conference, and the other functions of the Supreme Court to be incorporated in the appropriations submitted to the legislature. The Director prepares the necessary legislation to obtain the appropriation, and appears before the Appropriations Committees of the General Assembly to obtain passage of the necessary appropriation bills to provide the funds for the operation of the Court.


#### (d) Impartial Medical Expert Rule

Since the Supreme Court adopted an Impartial Medical Expert Rule on September 5, 1961 (Rule 17-2), the circuit courts and the trial lawyers throughout the State have increasingly invoked it as an aid to arrive at a just determination of a case. Prior to January 1, 1967, Rule 17-2 could only be invoked in a "personal injury case"; then in January of 1967 the Rule was renumbered as 215(d) and its scope broadened to apply to all civil cases. Accordingly, the use of the Rule increased from three cases in 1961 to sixty-two orders entered in 1967. During its existence, Rule 215(d) has been invoked on more than 225 occasions.

The purpose of the Rule is to serve as a discovery tool by allowing the court and lawyers to move for an impartial medical examination of a party whose mental or physical condition is in issue if such examination will materially aid in the just determination of the case. To a great extent, this purpose has been accomplished because the circuit courts have discriminately invoked the Rule. And while the Administrative Office is charged with administering the Rule, much of the credit for its success belongs to the Illinois State Medical Society which maintains a panel of physicians who have volunteered to participate in the Rule. Without the cooperation of the State Medical Society, the Rule could not achieve its objective.

The 1968 Statistical Summary set out below is self-explanatory, but several items should be noted: The fact that the number of Impartial Medical Expert (IME) examinations exceeds the number of IME orders entered during 1968, is explained by considering that some orders provided for examinations of more than one party in the case and that eight 1967 orders resulted in examinations in 1968, although six 1968 orders provided for 1969 examinations.

Further, the IME panelists' average fee per examination includes costs ancillary to the examination, e.g., pathology, radiology, psychology, etc. However, where an IME physcian used the services of another medical specialist, no recordation was made for the second physcian's specialty unless his services were more than incidental to completing the examination.



#### (e) Judicial Statistics

The compilation, analysis and publication of complete and meaningful judicial statistics is a very necessary adjunct to efficient court administration. Statistical reports for Cook County are kept in the Chicago office, and for the other 101 downstate counties in the Springfield office. Weekly reports are received from the presiding judge and each individual judge hearing divorce cases in Cook County. Monthly reports are received from all individual judges handling law jury trials in Cook County. These reports list every case handled and its disposition. Monthly reports are also received from all other divisions and departments in Cook County. Monthly reports are required from all downstate judges covering the types of work done and time consumed. The circuit clerk in each county sends in a monthly report of the number and types of all cases handled. A monthly report showing the trend of all cases in Cook County is issued, and a quarterly report is issued covering all circuits in the state.

#### (f) Information and Public Relations

Great numbers of questions and requests for information come from interested citizens, civic groups, schools, state officers, bar associations, other states and countries, lawyers, judges, law schools, newspapers and periodicals relating to our court system and our progress under the new Judicial Article. Dissemination of information, oral and written, has become a major and highly significant function of the office. In addition, foreign and out-of-state visitors avail themselves of the services of the office in their study of our judicial system.

#### (g) Legislative

The Supreme Court has now officially designated the Administrative Office as legislative liaison for the judicial system, and our office maintains a close working relationship with the Judicial Advisory Council of the General Assembly. Much time is spent on legislation affecting the courts and in exchanging information with the Judicial Advisory Council, the Governor's office, the Legislative Reference Bureau, and individual members of the legislature. During the legislative session, our office prepares a weekly synopsis of all bills affecting the courts or the administration of justice and furnishes copies of same to the Supreme Court and other members of the judiciary.

#### CONCLUSION

December 31, 1968 marked the end of my first year as Director of the Administrative Office. It is apparent from the duties and responsibilities added to the office since its creation on January 1, 1964 that the present staff is not sufficient to carry out all of the duties of the office. I have recommended and the Supreme Court has approved the addition of new positions in the office, which I hope the 1969 legislature will approve. Hopefully, we will be able to secure a full-time public information officer, an assistant director to work in the area of the model recordkeeping project, and an assistant director to assist in the Chicago office with the duties connected with the Judicial Conference and the administration of the Circuit Court of Cook County, and some additional secretarial help in both offices. With this increased Staff, I feel that the Administrative Office will be able to give a vital assist to the administration of justice in the State of Illinois.

In preparation for the increased size of the office, space has been obtained at the corner of Spring and Edwards Streets in Springfield for the relocation of the Administrative Office which is presently in the Supreme Court Building. The ground floor of this building in which the Accounting Division has previously been housed was occuped by the Administrative Office in December.

The mailing address remains at the Supreme Court Building in Springfield. The location of the Accounting Division and the rest of the functions of the office in the same building will do much to increase the efficiency of the office.



SUPREME COURT OF ILLINOIS NUMBER OF PETITIONS FOR REHEARING 1950-1968







#### LAW JURY CASES OVER \$10,000

In 1968, the inventory of pending law jury cases decreased. The inventory reduction occurred this year despite the fact there were fewer terminations than last year, fewer trial judges than last year and fewer verdicts than during any of the past four years. Factors which contributed to the inventory reduction include the terminations achieved during the summer trial and pre-trial programs as well as the decrease in new cases filed. While it should be noted that the reduction in the number of cases begun in recent years has reduced the total inventory of pending cases, that reduction has no effect on the number of older cases waiting to be heard. All of these factors must be considered in analyzing the decreased inventory:

1. The number of new cases begun in the County Department, Law Divisions has decreased. The following chart shows the number of cases begun (new filings plus cases transferred) for each calendar year since 1964:

With the Clerk's help, we have reviewed all filings, transfers and reinstatements in the Law Division, County Department for the years 1962 through 1968. The Chart on the next page (page 58) showing Age of Pending Law Cases has been revised so that the figure titled "Total Filed" for Law Jury Cases over \$10,000 now reflects only cases newly filed or transferred during each such year. In previous reports "Total Filed" figure included cases reinstated during each year, as well as those newly filed or transferred during each year.
