What is Pretrial?

The pretrial phase of the criminal justice system begins when a person is accused of a crime and ends when the charges are resolved. Persons in the pretrial phase are presumed innocent.

Supervision


- monitoring of defendants released from custody



OSPS YEAR 1


OSPS Year 1 Footprint

● OSPS Counties (66)




OSPS Pretrial Services Regions

OSPS Consists of Two Divisions




Division of Performance Management
