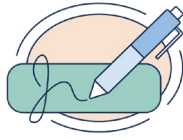

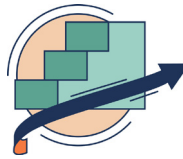

THEN:

Once you have filed your petition, you must publish notice of the name change in a newspaper in the county where you live. You must publish the notice at least once a week for three consecutive weeks. The newspaper will provide you with an affidavit of publication that you must file with the Clerk of the Circuit Court.

After filing your petition, you must serve notice of the name change to the other parent unless you qualify to waive notice. Then you will need to attend a hearing in front of a judge. The judge will review your petition and ask you some questions about the name change.
