A court may choose to not make available (or hide) Public-facing codes listed in this document if they are not used in their jurisdiction. The Public-Facing codes are to provide filers with a uniform set of codes to use when filing in each court and are NOT required or intended to be a standard for a court's case management or document management system. The Workgroup meets throughout the year to consider changes to the public-facing filing codes. The following procedures are used to manage Public-Facing Codes: Clerks can work with Tyler to hide or remove Public-facing codes that do not apply to their jurisdiction. Tyler will not add Public-Facing Codes for a jurisdiction without approval by the AOIC. - All Public-facing codes must be approved by the Workgroup to permanently add them for use by all courts. - Once approved by the Workgroup, a revised set of Trial Court Public-Facing Codes will be posted on the eFileIL website for use by courts and CMS partners. Section 2.1 Use of Temporary Codes A process has been created for courts to add Temporary codes that will be considered by the Workgroup, but have yet to be approved for use in all courts. The

A process has been created for courts to add remporary codes that will be considered by the workgroup, but have yet to be approved for use in an courts. The intent is to allow courts to address an immediate workflow if the codes they are suggesting have merit. However, the use / addition of Temporary Codes does not imply statewide adoption and could require the requesting court to remove them or make them 'Court-Use Only' codes if the Workgroup does not approve them for statewide use.
