M.R.031197 - In re: Anthony Campion Campanale. Disciplinary Commission.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. The petition by Anthony Campion Campanale for reinstatement to the roll of attorneys licensed to practice law in the State of Illinois pursuant to Supreme Court Rule 767. Denied.

M.R.031756 - In re: Alan Kent Wittig. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Alan Kent Wittig, who has been disciplined in the State of Arizona, is censured in the State of Illinois and placed on probation for one (1) year, subject to the conditions imposed upon respondent by the Supreme Court of Arizona and continuing until his period of probation in Arizona is successfully completed.

Respondent Alan Kent Wittig shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of probation.

M.R.031757 - In re: Philip Eugene Prewitt. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose reciprocal discipline pursuant to Supreme Court Rule 763. Allowed. Respondent Philip Eugene Prewitt, who has been disciplined in the State of Missouri, is suspended from the practice of law in the State of Illinois for two (2) years and until he is reinstated to the practice of law in the State of Missouri.

Suspension effective October 12, 2023.

Respondent Philip Eugene Prewitt shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

M.R.031768 - In re: James Thomas Rollins. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission for leave to file exceptions to the report and recommendation of the Review Board. Denied. Respondent James Thomas Rollins is suspended from the practice of law for five (5) months, as recommended by the Review Board.

Suspension effective October 12, 2023.

Respondent James Thomas Rollins shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct prior to the termination of the period of suspension.

M.R.031777 - In re: Alison H. Motta. Disciplinary Commission.

Motion by the Administrator of the Attorney Registration and Disciplinary Commission to approve and confirm the report and recommendation of the Hearing Board. Allowed. Respondent Alison H. Motta is suspended from the practice of law for ninety (90) days, with the suspension stayed in its entirety by a one (1) year period of probation, subject to the following conditions:

- a. Respondent shall successfully complete the ARDC Professionalism Seminar within the first six (6) months of probation;
- b. Respondent shall comply with the provisions of Article VII of the Illinois Supreme Court Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct, and shall timely cooperate with the Administrator in providing information regarding any investigation relating to her conduct;
- c. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the

Commission for the costs of this proceeding, as defined in Supreme Court Rule 773, and shall reimburse the Commission for any further costs incurred during the period of probation;

- d. Respondent shall attend meetings as scheduled by the Commission probation officer;
- e. Respondent shall notify the Administrator within fourteen (14) days of any change of address; and
- f. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The ninety (90) day period of suspension shall commence from the date of the determination that any term of probation has been violated.

Respondent Alison H. Motta shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from her conduct prior to the termination of the period of suspension/probation.

M.R.031786 - In re: Anthony V. Boyle. Disciplinary Commission.

Petition by the Administrator of the Attorney Registration and Disciplinary Commission to impose discipline on consent pursuant to Supreme Court Rule 762(b). Allowed. Respondent Anthony V. Boyle is suspended from the practice of law for two (2) years and until further order of the Court, with the suspension stayed in its entirety by a four (4) year period of probation, subject to the following conditions:

- a. Respondent shall comply with the provisions of Article VII of the Illinois Supreme Court Rules on Admission and Discipline of Attorneys and the Illinois Rules of Professional Conduct and shall timely cooperate with the Administrator in providing information regarding any investigations relating to his conduct;
- b. Respondent shall reimburse the Commission for the costs of this proceeding as defined in Supreme Court Rule 773 and, at least thirty (30) days prior to the termination of the period of probation, shall reimburse the Commission for any further costs incurred during the period of probation;

- c. At least thirty (30) days prior to the termination of the period of probation, respondent shall reimburse the Client Protection Program Trust Fund for any Client Protection payments arising from his conduct;
- d. Respondent shall notify the Administrator within seven (7) days of any arrest or charge alleging his violation of any criminal or quasi-criminal statute or ordinance;
- e. Respondent shall attend meetings as scheduled by the Commission probation officer. Respondent shall submit quarterly written reports to the Commission probation officer concerning the status of his practice of law and the nature and extent of his compliance with the conditions of probation;
- f. Respondent shall notify the Administrator within fourteen (14) days of any change of address;
- g. Probation shall terminate without further order of court provided respondent complies with the conditions of this order;
- h. Respondent shall abstain from the usage of alcohol and any unprescribed controlled substances;
- i. Respondent shall, as required by the Administrator, submit to random substance testing by a qualified mental health professional or facility approved by the Administrator, within eight (8) hours of receiving notice by the Administrator to submit to the testing or with daily breath testing with an Administrator approved testing device. The results of the tests shall be reported to the Administrator. Respondent shall pay any and all costs of such testing;
- j. Respondent shall begin a course of treatment with a qualified mental health professional acceptable to the Administrator and shall report to that professional on a regular basis with the Administrator advised of any change in attendance deemed warranted by such professional;
- k. Respondent shall comply with all treatment recommendations of the qualified mental health professional, including the taking of medications as prescribed;

- l. Respondent shall provide to the qualified mental health professional, an appropriate release authorizing the treating professional to: (1) disclose to the Administrator on at least a quarterly basis information pertaining to the nature of respondent's compliance with any treatment plan established with respect to respondent's condition; (2) promptly report to the Administrator respondent's failure to comply with any part of an established treatment plan; and (3) respond to any inquiries by the Administrator regarding respondent's mental and emotional state or compliance with any established treatment plans;
- m. Respondent shall come under the auspices of a primary care physician. That physician shall be apprised of respondent's chemical dependency and psychiatric history;
- n. Respondent shall comply with all treatment recommendations of the primary care physician, including taking medications as prescribed;
- o. Respondent shall provide to the primary care physician an appropriate release authorizing the treating professional to: (1) disclose to the Administrator on at least a quarterly basis information pertaining to the nature of respondent's compliance with any treatment plan established with respect to respondent's condition; (2) promptly report to the Administrator respondent's failure to comply with any part of an established treatment plan; and (3) respond to any inquiries by the Administrator regarding respondent's physical, mental or emotional state or compliance with any established treatment plans;
- p. Respondent shall participate in a 12-step program such as Cocaine Anonymous, Narcotics Anonymous, Alcoholics Anonymous and/or the Lawyer's Assistance Program, by attending at least two (2) in-person meetings a week. Respondent is to maintain a log of his attendance at the meetings and submit it to the Administrator with his quarterly reports;
- q. Respondent shall maintain a sponsor in the 12-step program and shall provide the name, address, telephone number and email address of the sponsor to the Administrator within fourteen (14) days of

being placed on probation. Respondent shall request that the sponsor communicate with the Administrator in writing on a quarterly basis regarding respondent's participation and progress in the 12-step program and report any lapses in sobriety or usage of unprescribed controlled substances to the Administrator within seventy-two (72) hours of the sponsor's knowledge of that usage;

- r. Respondent shall participate in a professional addiction aftercare support program approved by the Administrator on a weekly basis for at least the first year of his probation. Respondent shall provide to the Administrator the name, address, telephone number and email address of the aftercare provider within fourteen (14) days of being placed on probation. Respondent shall request that the provider communicate with the Administrator in writing on a quarterly basis regarding respondent's participation and progress and report any lapses in sobriety or usage of unprescribed controlled substances to the Administrator within seventy-two (72) hours of the provider's knowledge of that usage;
- s. Respondent shall report to the Administrator any lapse in his sobriety or usage of any unprescribed controlled substance within seventy-two (72) hours of that usage;
- t. Respondent shall notify the Administrator within fourteen (14) days of any change in treatment professionals;
- u. Respondent shall, within the first sixty (60) days of probation, enroll in a mentoring program, approved as a sponsor by the Illinois Supreme Court Commission on Professionalism and acceptable to the Administrator. Upon enrollment, respondent shall notify the Administrator, in writing, of the name of the mentor with whom respondent is assigned to work. Respondent shall successfully complete the mentoring program at least thirty (30) days prior to the end of the term of probation;
- v. Within the first thirty (30) days of the period of probation, respondent shall complete at least four (4) hours of continuing legal education on topics to include client trust accounts and fees, cost and billing

and shall provide proof of his attendance to the Administrator;

- w. Within the first year of probation, respondent shall complete and provide proof to the Administrator of the payment of restitution in the following amounts to the following individuals: \$3,500 to James Olalusi; \$5,000 to Traci Archbold; \$7,500 to Theodore Parish; and \$3,500 to Federico Castillo; and
- x. Probation shall be revoked if respondent is found to have violated any of the terms of probation. The remaining portion of the two (2) year period of suspension shall commence from the date of the determination that any term of probation has been violated and shall continue until further order of the Court.
