The Hon. Thomas L. Kilbride (Ret.) Judicial Access to Justice Award

The Hon. Thomas L. Kilbride (Ret.) Judicial Access to Justice Award will be given to a member of the judiciary who has made a significant or meaningful contribution to increasing access to the court system by improving the experience of litigants.

This award honors Justice Kilbride who was elected to the Illinois Supreme Court in 2000 and was elected Chief Justice by his colleagues in 2010. As Chief Justice, he spearheaded efforts to increase access to the court system for all court patrons. Under his leadership, in June of 2012 the Supreme Court established the Illinois Supreme Court Commission on Access to Justice (Commission). Justice Kilbride served as the Commission's liaison to the Supreme Court and was its leader in developing improvements, resources, and programs within the judicial system with the goal of fairness and equity.

Since its creation, the Commission has taken groundbreaking steps towards achieving equitable justice for all. Two important cornerstones of the Commission's work include initiatives on language access and the publication of plain language standardized forms. The Commission also drafted the Illinois Supreme Court Policy on Plain Language, the Illinois Supreme Court Policy on Assistance to Court Users, and the Illinois Supreme Court Policy on Remote Court Appearances in Civil Proceedings.

In furtherance of Justice Kilbride's goal, the Commission also created the Court Navigator Network, the first ever statewide network of court personnel dedicated to addressing issues affecting self-represented litigants. Under his tenure, the Commission launched other innovative programs including video remote interpreting, early resolution programs, online dispute resolution programs, and the state's first civil appellate help desk. With Justice Kilbride's assistance, the Commission began a biannual Law Student Leaders Access to Justice Summit – a day focused on educating future leaders about equalizing access to our judicial system in their respective career paths. The Commission has additionally lent its support to Illinois JusticeCorps, limited scope representation, and remote appearance endeavors.

None of these accomplishments would have been possible without Justice Kilbride's continued efforts, support, and dedication to the mission of access to justice. Justice Kilbride undoubtedly paved the way for a more fair, just, and equitable Illinois court system.

The questions on the electronic form include the following questions listed here to aid in your preparation of the nomination.

Please explain why you are nominating this individual. This narrative should include specific examples of how the nominee has made tangible and measurable efforts to improve the experience self-represented, limited English proficient, disabled, or otherwise vulnerable litigants have with the court system.

Standout nominees will have been involved in efforts to: implement a court-wide innovative program to address specific needs, taken steps in improve the process for litigants, increase litigants' understanding of court processes and procedures; connect litigants with necessary resources regarding substantive areas of the law; provide technology or language support; educate fellow colleagues on access to justice issues, or secure access to legal assistance or representation. The nominee's work will have improved vulnerable litigants' ability to meaningfully participate in their court cases. While there are no constraints as to how the nominee will have achieved this, it will likely be through a local or statewide program or change at the systemic level.
