See Local Rule 106: Appellant(s) will receive a total of 15 minutes for their main argument, the Appellee(s) will receive a total of 15 minutes for their response, and the Appellant(s) will receive a total of 5 minutes for their rebuttal. A Cross-Appellant's attorney receives 5 minutes to reply following the Appellant's reply. Any proposed deviation in length, or division of time amongst co-counsel, shall be requested via written motion. The motion shall include a specific proposal and be filed at least 7 days before the oral argument.

**BRIEFS, ETC.:** The briefs in each case have been thoroughly reviewed by the Justices of the Appellate Court prior to this day of Oral Argument.
