In re: Illinois Judicial College Committee on Pretrial Education

**Charge**

Consistent with the Bylaws of the Supreme Court of Illinois Judicial College, and the direction of the Illinois Judicial College Board of Trustees, the Committee on Pretrial Education (CPTe), shall promote comprehensive pretrial education as an aid to the Illinois judicial branch in its preparedness and readiness to interpret and apply the law, including Public Acts 101 – 652 and 102 – 1104, effective September 18, 2023, and develop ongoing continuing education and educational opportunities to overview and discuss the substantive and procedural law, rules, materials and pretrial resources.
