In re: Record on Appeal for Hearings Conducted Pursuant to the Pretrial Fairness Act

Order

Whereas Public Act 102-1104 establishes 725 ILCS 5/110-6.6 – *Appeals*, recognizing that appeals under this Article shall be governed by Supreme Court Rules and concerning hearings conducted by means of two-way audio-visual communication or other electronic recording system and use of the audio-visual recording as the report of proceedings for the purpose of appeal; and given the anticipated resources necessary to implement the Pretrial Fairness Act (P.A. 101-652 and P.A. 102-1104):

IT IS HEREBY ORDERED THAT:

1. This order applies to all appeals under 725 ILCS 5/110-6.6.
2. If there is an official recording of the proceedings, the recording shall be used as the official report of proceedings on appeal. This order does not prohibit a transcription by a court reporter from also being entered into the record.
3. Where an official recording is used as the official report of proceedings, court reporting personnel shall:
  - i. Arrange for extraction of the relevant portion of proceedings in .mp4 format for audio-visual recordings, or in .wav or .mp3 format for audio only recordings.
  - ii. Create the official log of the recorded report of proceedings. The log shall contain the digital file name(s), case caption, trial court number, the number of files from the proceedings (e.g., 1 of 5), and mode of media storage (e.g., CD or flash drive). The log shall designate by reference to

time stamps the points at which direct or subsequent examinations of witnesses commence and conclude.

- iii. Transmit the recorded report of proceedings, official log, and certification of the court reporting personnel to the clerk of the circuit court.
4. If it deems necessary, the reviewing court may order transcription of any part of a recorded report of proceedings.
5. The clerk of the circuit court shall transmit the recorded report of proceedings to the reviewing court in accordance with the provisions for transmitting electronic media exhibits under the Supreme Court of Illinois Standards and Requirements for Electronic Filing of the Record on Appeal.
6. When making citations to the recorded report of proceedings, litigants shall reference the time stamp corresponding to the cited section.

This order shall take effect on January 1, 2023, or on such other date as the Pretrial Fairness Act provisions of P.A. 101-652 and P.A. 102-1104 become effective and shall remain in effect until further order of the Court.
