Re: Electronic Citation and Complaint Form

Dear Ms. Grant:

Effective January 1, 2025, Public Act 103-0789 requires that all Illinois Citation and Complaint Forms include an admonishment that a defendant's failure to appear in court may lead to significant consequences impacting the violator's driving privileges.

In compliance with these new requirements under 625 ILCS 5/6-308, the Illinois Uniform Citation and Complaint Form has been updated accordingly by modifying the Notice to Appear language as follows:

NOTICE TO APPEAR

The results of your failure to appear or pay this ticket is based on whether your ticket is marked "Court Appearance Required" or "No Court Appearance Required" and may result in either a judgment of conviction being entered against you for fine penalties, assessment, and cost as provided in the NOTICE OF CONSENT FOR ENTRY OF JUDGMENT; or, the court may order <u>a</u> warrant to be issued, <u>other significant consequences affecting your driving privileges</u>, or you may be tried and sentenced in your absence.

Effective January 1, 2025, all agencies must update their electronic citation programs to comply with the new standards. Agencies using paper citation forms may continue to use their existing stock approved on September 1, 2023, provided they apply a sticker over the "Notice to Appear" admonishments on the Violator copy until updated forms with the required revisions are ordered.

The Notice of Consent for Entry of Judgment has been updated to provide clearer language, and this revised version has been incorporated into the Electronic Printing Instructions.

Additionally, the Electronic Printing Instructions now include specific guidance for citations issued through automated traffic control systems. In compliance with the Automated Traffic Control Systems in Highway Construction or Maintenance Zones Act, violators must be informed that the citation was generated by an automated traffic control system.

The Conference of Chief Circuit Judges (Conference) approved these amendments on December 6, 2024. On behalf of the Conference, I hereby submit the amended Electronic Citation and Complaint Form, effective immediately.

Guidelines

Implementation of Electronic Citation Program

The implementation of an Electronic Citation Program (e-Citation) is authorized in any county, except Cook County, within the State of Illinois by the Illinois State Police. The ISP may implement the approved electronic citation program using an $8 \frac{1}{2}$ " x 11" citation form, which must be accepted for filing by circuit clerks in the remaining 101 Illinois counties.

The implementation of an e-Citation program by local law enforcement may be authorized in any county upon the submission of a written request from each law enforcement agency to the Chief Judge of the Circuit (Chief Judge) and the Clerk of the Circuit Court (Circuit Clerk).

The following criteria shall be met by each vendor and e-Citation program prior to implementation being authorized by the Circuit Clerk:

- □ The Circuit Clerk has been approved and is actively participating in the Automated Disposition Reporting Program. In the event that the Automated Disposition Reporting Program is suspended after an e-Citation program is implemented, appropriate procedures must be implemented to ensure proper reporting of disposition information to the recipient agencies during the suspension.
- □ The citation form and format shall meet the standards for electronic citations approved by the Conference of Chief Circuit Judges (Conference) and filed with the Clerk of the Supreme Court pursuant to Supreme Court Rule 552.
- □ Identify the vendor performing the electronic citation functions and include a copy of each page of the citation form indicating the type of paper (bond or thermal) to be used.
- The application for court supervision and/or traffic safety school for counties which have been authorized to accept supervision by mail pursuant to Supreme Court Rule 529(b) must meet the requirements of Supreme Court Rules and the Traffic Safety Program Standards adopted by the Conference.
- \Box Each citation shall be filed with the Circuit Clerk and contain the signature of the issuing officer.
- □ Electronic filing may be applied as authorized by the Supreme Court.
- □ Data and document exchange formats may be implemented at the discretion of the Circuit Clerk.

Printing Instructions

ILLINOIS e - CITATION AND COMPLAINT

PRINTING and DISPLAY INSTRUCTIONS

The attached electronic citation, hereafter referred to as the "e-Citation," document is a copy which does not purport to reflect either spacing or size of type and therefore the following is provided.

(1) **<u>DIMENSIONS</u>**

The overall dimension of the uniform e-Citation form may conform to the paper citations filed with the Clerk of the Supreme Court which may be printed on $8\frac{1}{2} \times 11$ paper, or printed as a continuous form approximately $4\frac{1}{2}$ inches in width.

If 8 $\frac{1}{2}$ x 11 paper is used, a two-column format is required. The citation shall appear on approximately the left $\frac{4}{2}$ inches of the page. The instructions to the violator shall appear on the right side of the page.

If a continuous form is used, the citation shall appear first, followed by the instructions to the violator or the instructions may appear on the reverse side of the citation. This format shall be used for each copy of the e-Citation required to be printed as provided in Number 3, below.

(2) **DEFINITION(S)**

The definition of "paper" for an e-Citation must be in compliance with Supreme Court Rule and Illinois law and have a minimum of 20-year life quality.

(3) <u>NUMBER OF COPIES TO BE PRINTED</u>

The following information shall be printed on the three (3) copies of the e-Citation.

- (a) Complaint Copy Citation Face, Instructions to the Violator, Notice to Appear-Admonishments to the Violator, and Notice of Consent for Entry of Judgment.
- (b) Violator Copy Citation Face, Instructions to the Violator, Notice to Appear-Admonishments to the Violator, Notice of Consent for Entry of Judgment, and, if applicable, Optional Instructions for Agencies Exempt from Supreme Court Rule 505.
- (c) Court Communication Copy Citation Reference, Avoid Multiple Court Appearances, Guilty Plea and Waiver, and, if applicable, Optional Instructions for Agencies Exempt from Supreme Court Rule 505.

The Violator and Court Communication copies of the citation shall be printed at the time of issuance. Additional copies of the citation may be printed at the request of the violator, as required by the clerk for disposition reporting, or as may be desired by the issuing agency, thereafter.

(4) FACE OF THE CITATION

General Instructions

- (a) All printing on the e-Citation shall be in black.
- (b) There shall be six (6) specific boxes provided on each e-Citation. Each box shall be labeled vertically on the left side of the e-Citation (as provided in the sample Citation Forms in this packet) or horizontally in the upper left corner of the box.
 - i. Complaint Box
 - ii. Defendant Box
 - iii. Vehicle Box
 - iv. Violation Box

- v. Incident Box
- vi. Notice to Appear Box
- (c) Only one violation shall be printed on each e-Citation.
- (d) When content on the e-Citation has multiple value options, only the value(s) that the officer selects, as provided herein, shall be printed on the citation.

Each of the boxes shall contain the information as it appears on the attached e-Citation form. Codified fields identified in Appendixes E - I may be printed showing the literal display portion of the data or the preceding 3-letter code (e.g., BLK-Black would be printed as "Black"). The following fields may contain data that must be adjusted according to the text length, should be dynamically sized according to the text required to be displayed: the date and time of the violation, the specific location of the violation, the actual and posted speed limits, the Report Number section, and the Notations section.

- (e) Complaint Box
 - i. The words "Illinois Citation and Complaint - Illinois State Police" (or other issuing agency) shall be printed at the top of each copy of the e-Citation.
 - ii. A unique issuing agency e-Citation Number shall be printed in the upper right corner in a minimum of 14 point font.
 - iii. The title of the e-Citation copy (e.g., COMPLAINT) shall be printed below the DCN data box and in the same font size as the issuing agency e-Citation Number.
 - iv. ISP District of Occurrence and Assignment may be replaced with appropriate Beat/Section identifiers of the issuing agency.
 - v. A bar code may (optional) be printed above the case number field.
 - vi. "TWP. RD." and checked box shall be printed, when applicable.
 - vii. One of two check boxes shall be marked and printed to identify the charging entity (People State of Illinois or City/Village of Municipal Corporation, Plaintiff).
- (f) Defendant Box
 - i. Defendant Height shall appear in Feet (') and Inches (") with the appropriate single or double quotes.
 - ii. Defendant Weight shall appear in pounds.
 - iii. Defendant Eyes (i.e., eye color): shall use the list provided in Appendix E: Defendant Eye Color.
 - iv. Defendant Hair (i.e. hair color): shall use the list provided in Appendix F: Defendant Hair Color.
 - v. CDL Box shall contain one of two codes: "Y" if the Defendant has a CDL license and contain an "N" if the Defendant does not have a CDL license. It shall not be defaulted to "N," but require the user to select the appropriate value.
 - vi. Defendant Gender as specified in 625 ILCS 5/6-106. (e.g. M, F or X)
- (g) Between the Defendant and Vehicle Boxes the following text shall be printed.

"The Undersigned states that on *(date)* at *(time, AM or PM)* defendant did unlawfully operate:"

(h) Vehicle Box

- i. Vehicle Type: shall use one or more of the vehicle types provided in Appendix G: Vehicle Type, as appropriate.
- ii. Vehicle Color: shall use the list provided in Appendix H: Vehicle Color, shall appear on the same line as the vehicle for which it applies, as appropriate.
- iii. Vehicle Use (Commercial Motor Vehicle, Placarded Haz. Material, and 16 or More Pass. Vehicle): shall be printed as it appears on the sample e-Citation form, and shall not be defaulted to "no," but require the user to select the appropriate value for each of the vehicle use options.
- (i) Between the Vehicle and Violation Boxes the following text shall appear:

"or, as a Pedestrian or Passenger, and upon a Public Highway, or other Location, Specifically <u>(specific location)</u> located in the County and State Aforesaid and Did Then and There Commit the Following Offense." When applicable, a check box and the words "Urban District" shall be printed as identified on the citation sample.

- (j) Violation Box
 - i. This box shall contain only a single violation.
 - ii. One of two check boxes must be marked and printed to identify the level of government of the violation (i.e., ILCS or Local Ordinance).
 - iii. If an Illinois Compiled Statute (ILCS) is cited, the full ILCS citation containing Chapter, Act and Section/Paragraph must be formatted and printed as required by law (i.e., 625 ILCS 5/11-601(b)).
 - iv. If a Local Ordinance is cited, the full local ordinance citation must be formatted and printed as codified by the local municipality.
 - v. For a speeding violation (e.g., 625 ILCS 5/11-601(b), 11-601.5, etc.), the posted limit and vehicle speed must be printed as follows:

(actual) MPH in a (posted) MPH Zone

- vi. Below the cited violation, a literal notation for the Nature of Offense shall be printed. Abbreviations or acronyms shall not be used.
- vii. The applicable seven digit Offense Code identified in the AOIC Offense Code Table may be included and printed immediately following the ILCS or local ordinance citation, as follows: Offense Code: (7 digit code).
- (k) Incident Box
 - i. Crash Type must be printed with the appropriate selection from the options below:
 - □ Space or None
 - □ I-Driver Injury Only
 - □ V-Vehicle/other property damage
 - □ P-Personal Injury
 - D-Death/Fatal
 - ii. Report Number(s)

This is the field report number or crash report number, if any, completed by the officer as specified by the issuing agency. The "Report No." label may be modified to display the type of report, (i.e. "Field Report No., Crash Report No.").

- Road Conditions, Visibility, and Method: One or more of the applicable road conditions, visibility, and method may be selected from Appendix I Incident Section: Road Conditions, Visibility, and Method.
- iv. Notations: Notations are optional.

Automated traffic control system citations shall include the following notation: "PHOTO ENFORCMENT VEHICLE IN WORK ZONE WHILE WORKERS PRESENT" as provided for under the Automated Traffic Control Systems in Highway Construction or Maintenance Zones Act.

- (l) Notice to Appear Box
 - 1. Only the method of release issued to the violator shall be printed. Mark and print the appropriate requirement on the e-Citation, in a minimum of 14 point font, as follows:
 - a. Pre-Trial Release: Detained: Location:
 - b. No Court Appearance Required
 - c. Court Appearance Required
 - 2. When one of the following methods of release is printed, the appropriate statement shall be printed in black text <u>immediately below</u>, as follows:
 - a. If Court Appearance Required is the method of release: You are required to come to court on the date, time and place noted below. If you intend to plead "NOT GUILTY", follow the instructions on the form entitled "Avoid Multiple Court Appearances" prior to your court date
 - b. If No Court Appearance Required is the method of release: If you intend to plead "GUILTY" and avoid coming to court, follow the instructions to plead GUILTY and waive your court appearance. If you intend to plead "NOT GUILTY", follow the instructions on the form entitled "Avoid Multiple Court Appearances" prior to your court date and come to court on the date, time and place noted below.

For agencies exempt from Supreme Court rule 505, a checkbox with the following text may be printed in the Notice to Appear box in lieu of the court date.

"The clerk of the court will notify you of your court date which shall be not less than 14 days but within 60 days of the date of the arrest, whenever practicable."

- (m) Notice to Appear Box
 - 1. "CIRCUIT COURT LOCATION, DATE, and TIME" shall be printed in this box. Additionally, the following information shall be printed.
 - i. The name of the circuit court in which the violator is to appear.
 - ii. The address for the court location, which shall include:
 - a. Any branch or district, where applicable
 - b. Street number and street name
 - c. City, State, and Zip Code
 - iii. The appearance date
 - iv. The appearance time, including the appropriate AM or PM indication.
 - v. The courtroom number, where available.
- (n) The officer must also sign the citation, as authorized. After the Notice to Appear Box the text for the officer's verification and signature shall be printed, as follows.

"Under penalties as provided by law for false certification pursuant to Section 1-109 of the Code of Civil Procedure and perjury pursuant to Section 32-2 of the Criminal Code of 2012, the undersigned certifies that the statements set forth in this instrument are true and correct."

(5) INSTRUCTIONS TO THE VIOLATOR

The Complaint and Violator copies of the e-Citation shall include specific instructions to the violator regarding directions based upon the e-Citation issued, as specified in this Section and Sections 6 and 7 of these Instructions.



The Electronic Citation (e-Citation) Data Layout and Exchange Formats are provided for those counties approved by the Conference of Chief Circuit Judges to implement an e-Citation Program which requires reporting dispositions through the Automated Disposition Reporting (ADR) Program of the Administrative Office of the Illinois Courts. The following table provides the data layout for the exchange of information between the e-Citation vendor and Clerk of the Circuit Court (Circuit Clerk). The Format Minimums are different from the ADR data formats required for reporting dispositions to the respective state entities. The Circuit Clerk must ensure the data is properly converted to the format approved for ADR, as specified in the Administrative Office of the Illinois Courts' ADR Data Dictionary, when generating the disposition file.
