

NOTICE OF VACANCY ASSOCIATE JUDGE, FIFTH JUDICIAL CIRCUIT

The Chief Judge of the Fifth Judicial Circuit has received authorization pursuant to Illinois Supreme Court Rule 39 to post a Notice of Vacancy for the position of Associate Judge. The vacancy results from the retirement of Hon. Derek J Girton as an Associate Judge, effective at the close of business on July 2, 2024. Applications for this vacancy are now being accepted, which will be filled by vote of the Circuit Judges of the Fifth Judicial Circuit.

Pursuant to Supreme Court Rule 39, any attorney, who is a United States citizen, is licensed to practice law in the State of Illinois, and is a resident of the Fifth Judicial Circuit may apply by electronically filing a signed application with the Director of the Administrative Office of the Illinois Courts on the form prescribed and furnished by the Director. PLEASE BE ADVISED THAT THE APPLICATION FORM WAS REVISED ON SEPTEMBER 17, 2019 AND ONLY APPLICATIONS ON THE REVISED FORM WILL BE ACCEPTED.

Whether electronically filed, mailed or hand delivered, all applications must be **received** in the Administrative Office within 30 days after the date of this Notice. **If filed electronically, the deadline is 11:59 p.m. on April 4, 2024. If mailed or hand delivered, the deadline is 5:00 p.m. on April 4, 2024.** A form for application may be obtained from either the Chief Judge's Office, the Administrative Office of Illinois Courts, or from the Illinois Supreme Court website: <http://illinoiscourts.gov> and downloaded from the Judicial Vacancies link. **Applications will not be accepted if submitted via facsimile.**

Applicants may be required to make themselves available for an interview with the Circuit Judges of the Fifth Judicial Circuit. If an interview is requested, the applicants will be notified of the date, time, and place of their interview at the close of the application period. Applicants are to refrain from contacting any Circuit Judge regarding their candidacy. A Circuit Judge, however, may contact any applicant.
