Promoting civil pathways to outpatient mental health care

The reality of accessing mental health care is such that the majority of services are provided to individuals in a community or outpatient setting. In Illinois, there are two common conduits for outpatient care: involuntarily or through an agreed care and custody order. Outpatient admission can be sought as a stand-alone remedy for an individual residing in the community already, or for someone who is inpatient at a mental health facility (whether voluntary or involuntary).
