ADMINISTRATIVE ORDER 2021 - 11

On May 27, 2021 the Illinois Supreme Court in M.R. 30370 amended its earlier orders of March 17, 2020 and August 27, 2020 to be consistent with current public health practices and recommendations, whereby wearing a mask or face covering is no longer mandated in certain settings and under certain conditions. Ogle County Administrative Order #2020-17 is amended as follows:

1. Individuals entering the Ogle County Judicial Center courtrooms, immediate adjacent areas and chambers area need not wear a mask or face covering if they are fully vaccinated. Within the court facilities, all individuals including judges, court staff, attorneys, jurors and members of the public shall maintain at least a six foot social distancing from other individuals unless fully vaccinated.
2. Remote hearings may be continued to be allowed consistent with the policy set forth in Administrative Order #2020-15.
3. Any limitation on litigant or public attendance not inconsistent with this order is vacated.
4. Any limitation on the number of people attending marriages is vacated.
5. Any limitation on accessibility to the law library and SLR room is vacated.
6. Any limitation on judicial tours is vacated.
7. Restrictions on attorney access to the back hallway and chambers area remains in place. Admittance is allowed with the consent of a judge.
8. This Administrative Order shall be effective June 2, 2021.

In accordance with Supreme Court Order No. 30370 entered on March 17, 2020, and as amended on August 27, 2020, and May 27, 2021,

IT IS HEREBY ORDERED, EFFECTIVE JUNE 1, 2021:

Entry into courtrooms:

- A. Individuals, including judges, court staff, parties, attorneys, spectators and witnesses are not to enter any courtroom if they:
1. Have new flu-like symptoms including fever, cough, or shortness of breath (excluding such symptoms caused by chronic conditions).
 2. Currently have been directed to quarantine or isolate at home by any medical provider or public health official.
 3. Reside or have regular contact with a person currently subject to a quarantine or isolation direction issued by a medical provider or public health official and are not themselves fully vaccinated.
- B. Who is REQUIRED to wear a mask or face covering:
Individuals, including judges, court staff, parties, attorneys, spectators and witnesses that have **NOT** been vaccinated against COVID-19 or have been vaccinated against COVID-19, but are **NOT** two weeks past their final vaccination injection.
- C. Who is NOT REQUIRED to wear a mask:
Individuals, including judges, court staff, parties, attorneys, spectators and witnesses that have been vaccinated against COVID-19 and are two weeks past their final vaccination injection.
