Re: Uniform Citation and Complaint Form

Dear Ms. Grant:

The Secretary of State is preparing to incorporate Gender X designation on Driver's License and identification cards as of October 1, 2023, as result of Public Act 101-513. Accordingly, the Illinois Uniform Citation and Complaint Form has been amended to comply with the provisions of 625 ILCS 5/6-106.

The former Male and Female checkboxes have been replaced with a blank text box for officers to record the gender of "M" for Male, "F" for Female, or "X" for Gender X or Non-Binary.

Agencies are allowed to use their existing stock of the citations filed October 27, 2022 until their next order. While using the previous version's citation, if an Officer receives a driver's license or identification card with the Gender X designation, they shall record the Gender X designation in the notes field instead of recording the gender in the Defendant Section.

The Conference of Chief Circuit Judges (Conference) approved these amendments electronically on August 18, 2023. On behalf of the Conference, I hereby submit the amended Uniform Citation and Complaint Form, effective immediately.

Re: Revised Implementation Date for the Uniform Citation and Complaint Form

Dear Ms. Grant:

As result of the Supreme Court's Opinion, 2023 IL 129248 Rowe v. Raoul (effective September 18, 2023) which upheld the provisions of the SAFE-T Act, the Conference of Chief Circuit Judges (Conference) approved at its meeting on July 21, 2023, a revised mandatory implementation date for the Uniform Citation and Complaint Form (Uniform Traffic Ticket) filed on October 27, 2022. On behalf of the Conference, I hereby submit the revised mandatory implementation date for the Uniform Citation and Complaint Form to January 1, 2024.

Agencies must contact their printing vendor to place an order as soon as possible to ensure the new citations are received and in use no later than January 1, 2024. Any Uniform Citation and Complaint forms issued on or after January 1, 2024 must conform to the changes of the SAFE-T Act.

Effective September 18, 2023, agencies may use their exiting stock through December 31, 2023 with the following limitations and conditions:

- 1. The only option for release is "Notice to Appear", otherwise if the violator is detained, the officer must indicate "Detained" and the location in the release box;
- 2. The violator signature is no longer collected; and
- 3. Bail is no longer accepted.

Effective January 1, 2024, all existing stock must be discarded, and all citation forms issued by any law enforcement agency must comply with the new form originally filed October 27, 2022.

### **PRINTING INSTRUCTIONS**

#### (UNIFORM TRAFFIC TICKET, UNIFORM CITATION)

THE ATTACHED DOCUMENT IS A COPY WHICH DOES NOT PURPORT TO REFLECT EITHER SPACING OR SIZE OF TYPE AND BECAUSE IT DOES NOT REFLECT APPROPRIATE COLORING FOR EACH LEAF, THE FOLLOWING INFORMATION IS PROVIDED:

(1) <u>DIMENSIONS</u>. THE OVERALL DIMENSION OF THE UNIFORM CITATION FORM SET WILL BE FOUR AND THREE-FOURTHS INCHES (4 3/4") IN WIDTH BY TEN INCHES (10") IN LENGTH. INCLUDED IN THE LENGTH (10") IS A THREE-FOURTHS INCH (3/4") PERFORATED TEAR-OFF STRIP AT THE TOP AND A FIVE-EIGHTS INCH (5/8") PERFORATED TEAR-OFF STRIP AT THE BOTTOM.

(2) <u>NUMBER OF LEAVES AND COLOR OF PAPER</u>. EXCEPT AS PROVIDED BELOW, ALL UNIFORM CITATIONS SHALL INCLUDE THE FOLLOWING SIX LEAVES WHICH SHALL BE PRINTED ON THE COLOR OF PAPER AS FOLLOWS:

1. <u>COMPLAINT</u> COPY	WHITE
2. <u>REPORT OF CONVICTION</u> COPY	CANARY
3. <u>COURT DISPOSITION</u> COPY	WHITE
4. <u>POLICE RECORD</u> COPY	GREEN
5. <u>VIOLATOR</u> COPY	GOLDEN ROD
6. COURT COMMUNICATION COPY	BLUE

UPON A WRITTEN REQUEST BY A LAW ENFORCEMENT AGENCY TO THE CLERK OF THE CIRCUIT COURT, THE CHIEF JUDGE OF THAT CIRCUIT MAY, WITH CONCURRENCE OF THE CLERK OF THE CIRCUIT COURT, REQUEST THE CONFERENCE OF CHIEF CIRCUIT JUDGES TO AUTHORIZE THE OMISSION OF THE <u>REPORT OF CONVICTION</u> COPY AND/OR <u>COURT</u> <u>DISPOSITION</u> COPY.

#### (3) FACE OF THE CITATION.

(a) ALL PRINTING ON THE FACE OF ALL COPIES OF THE UNIFORM CITATION WILL BE IN BLACK LETTERING, EXCEPT FOR THE FOLLOWING:

- (1) THE FOLLOWING WILL BE PRINTED AS A <u>RED</u> BAR WITH <u>WHITE</u> LETTERING:
  - (a) TITLES TO EACH BOX
  - (b) TITLE TO THE VEHICLE USE BOX.
- (2) THE FOLLOWING WILL BE IN <u>RED</u> PRINT:
  - (a) THE TICKET NUMBER.
    - (b) THE TITLES TO EACH LEAF: <u>COMPLAINT</u>, <u>REPORT OF</u> <u>CONVICTION</u>, <u>COURT DISPOSITION</u>, <u>POLICE RECORD</u>, <u>VIOLATOR</u>, AND <u>COURT COMMUNICATION</u>.
    - (c) THE PRINTING CRASH <u>TYPE</u>, <u>DRIVER INJURY ONLY</u>, <u>PROPERTY DAMAGE</u>, <u>PERSONAL INJURY</u>, AND <u>FATAL</u> LOCATED WITHIN THE INCIDENT BOX.
  - (d) THE PRINTING OF THE WORDS PRE-TRIAL RELEASE: DETAINED, <u>COURT APPEARANCE REQUIRED</u> AND <u>NO</u> <u>COURT</u>

<u>APPEARANCE REQUIRED</u> WITHIN THE NOTICE TO APPEAR BOX

- (e) THE PRINTING OF THE WORDS IN THE VEHICLE USE SECTION.
- (f) THE PRINTING OF THE WORDS AND BOX FOR CDL INDICATION.
- (b) THE FOLLOWING OPTIONAL INFORMATION MAY BE ADDED TO THE FACE OF EACH LEAF:
  - (1) THE WORDS "ILLINOIS CITATION AND COMPLAINT -- ILLINOIS STATE POLICE" (OR OTHER APPROPRIATE WORDING IDENTIFYING THE LAW ENFORCEMENT ENTITY OR MUNICIPALITY, IN THE CASE OF FORMS PRINTED AND ADAPTED FOR USE BY A MUNICIPALITY) MAY BE PRINTED AT THE TOP OF EACH COPY OF THE FORM.
  - (2) A BAR CODE MAY BE PLACED ABOVE THE <u>CASE NO.</u> FIELD IN THE <u>COMPLAINT</u> BOX.
  - (3) PRINT THE ADDRESS OF THE COURTHOUSE IN THE <u>NOTICE TO</u> <u>APPEAR</u> BOX.
- (c) FOR AGENCIES EXEMPT FROM SUPREME COURT RULE 505, A CHECKBOX WITH THE FOLLOWING TEXT MAY BE PRINTED IN THE <u>NOTICE TO APPEAR</u> BOX IN LIEU OF THE COURT DATE. IT IS ACCEPTABLE TO INCORPORATE THE COURT LOCATION ON A SINGLE LINE TO ACCOMMODATE THE TEXT BELOW.

"THE CLERK OF THE COURT WILL NOTIFY YOU OF YOUR COURT DATE WHICH SHALL BE NOT LESS THAN 14 DAYS BUT WITHIN 60 DAYS OF THE DATE OF ARREST, WHENEVER PRACTICABLE."

- (d) THE PRINTING OF THE WORDS IN THE BOXES BELOW WILL BE SCREENED SO THEY CAN BE WRITTEN OVER:

  - (3) <u>NOTICE TO APPEAR</u> BOX: <u>CITY</u> AND <u>ZIP</u>, IF NOT PRINTED AS PROVIDED IN (3)(b)(3), ABOVE.
- (e) THE PERFORATED TEAR-OFF STRIP AT THE TOP AND AT THE BOTTOM OF THE <u>COMPLAINT</u> COPY OF THE UNIFORM CITATION SHALL HAVE IMPRINTED, IN BLACK, THE FOLLOWING WORDING:

ON THE PERFORATED TEAR-OFF STRIPS ON THE OTHER FIVE LEAVES, THE PRINTING OF THIS WORDING IS OPTIONAL.

(4) BACK OF THE CITATION.

- (a) APPROPRIATE PRINTING ON THE BACK SIDE OF THE <u>POLICE RECORD</u> COPY IS OPTIONAL.
- (b) THE PRINTING ON THE BACK SIDE OF THE COMPLAINT, REPORT OF

<u>CONVICTION</u>, <u>COURT DISPOSITION</u>, <u>POLICE RECORD</u>, <u>VIOLATOR</u>, AND <u>COURT COMMUNICATION</u> COPIES OF THE UNIFORM CITATION WILL BE IN BLACK LETTERING.

- (c) SPECIAL PRINTING INSTRUCTIONS FOR THE BACK SIDE OF THE <u>VIOLATOR</u> AND <u>COURT COMMUNICATION</u> COPIES OF THE UNIFORM CITATION FOR AGENCIES EXEMPT FROM SUPREME COURT RULE 505:
  - (1) THE TEXT ON THE BACK SIDE OF THE <u>VIOLATOR</u> COPY OF THE UNIFORM CITATIONMAY BE REPLACED WITH THE TEXT PROVIDED IN **APPENDIX A**.
  - (2) THE TEXT ON THE BACK SIDE OF THE <u>COURT COMMUNICATION</u> COPY OF THE UNIFORM CITATION MAY BE REPLACED WITH THE TEXT PROVIDED IN **APPENDIX B**, OR IF THE AGENCY WISHES TO ELIMINATE THE TOP BOX, "AVOID MULTIPLE COURT APPEARANCES," THE TEXT ON THE BACK SIDE OF THE <u>COURT</u> <u>COMMUNICATION</u> COPY MAY BE REPLACED WITH THE TEXT IN **APPENDIX C**.
- (d) COUNTIES AUTHORIZED FOR ILLINOIS VEHICLE CODE WAIVERS PURSUANT TO (725 ILCS 5/124A-20) MAY ELIMINATE THE FOLLOWING TEXT ON THE BACK SIDE OF THE <u>COURT DISPOSITION COPY</u>: "(NON-IVC VIOLATION ONLY)."
- (e) THE BACK OF THE <u>VIOLATOR COPY</u> MAY CONTAIN A QR CODE, PLACED ABOVE THE NOTICE TO APPEAR, THAT DIRECTS THE VIOLATOR TO A WEBSITE PROVIDING THE VIOLATOR WITH MORE INFORMATION REGARDING OPTIONS AVAILABLE TO SATISFY THE CITATION.

(5) NO ADDITIONAL MODIFICATIONS TO THE PRINTING OF THE UNIFORM CITATION ARE AUTHORIZED.


