## 1. OATH

On oath I promise that I will faithfully fulfill the duties and responsibilities of guardian of the minor named above. I understand that:

- I am responsible for the care, management, and investment of the minor's estate.
- I must keep records of the minor's income, assets, and expenditures, and I may be required to file periodic reports with the court.
- I must appear on behalf of the minor in any legal proceeding regarding the minor.
- I must notify the court and the minor's parents of any change in my address or the address of the minor within 30 days of the change.
- If I am appointed guardian of the person of the minor:
  - I am responsible for the health, welfare, and education of the minor.
  - I must get permission from the judge before moving out of state with the minor or traveling with the minor outside the state for more than 30 days.
  - I cannot transfer custody of the minor to anyone, including the minor's parents, without permission from the judge. I will file any reports the judge requires.

**2. BOND**

*Note: The bond amount should be double the value of the minor's estate for a bond without surety or an individual surety bond, and not less than 1.5 times the value of the personal estate for a corporate surety bond.*

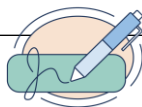
