

Using the Digital Signature Form

1. When you click the Digital Signature form option, you will be redirected to the Adobe Sign page where you will complete the Statement online. You must complete the digital signature field, date field, printed name field, and email field before the Statement can be submitted. Once these fields are completed, a blue 'Click to Sign' button will appear. If additional documentation is being attached to your Statement, click on "Click to Attach" before signing. The attachment can be uploaded as a Word.docx or PDF file.
