# AGREED MOTION FOR LEAVE TO FILE RECORD ON APPEAL IN LEAD CASE *ROWE v. RAOUL*, NO. 2022CH16, INSTANTER

Pursuant to Supreme Court Rules 326 and 361, Defendants-Appellants

Kwame Raoul, in his official capacity as Attorney General of the State of Illinois; JB

Pritzker, in his official capacity as Governor of Illinois; Emanuel Christopher Welch,
in his official capacity as Speaker of the Illinois House of Representatives; and Don

Harmon, in his official capacity as Illinois Senate President ("defendantsappellants"), by their attorneys, move this Court for leave to file the record on appeal
in the lead case, *Rowe v. Raoul*, No. 2022CH16 (Kankakee Cnty.), instanter, with the

remainder of the record to follow. All parties agree to the relief sought in this motion.

In support of this motion, defendants state the following:

- 1. This appeal arises from 64 consolidated civil cases challenging the Illinois Safety, Accountability, Fairness and Equity-Today ("SAFE-T") Act, Pub. Act No. 101-652 (2021). Plaintiffs are the state's attorneys (and, in some cases, sheriffs) of 64 counties, who brought facial challenges to the Act in the fall of 2022. Those cases were transferred and consolidated by this Court with the first-filed case, *Rowe v. Raoul*, No. 2022CH16, in the Circuit Court for the Twenty-First Judicial Circuit, in Kankakee County, Illinois. *See Rowe v. Raoul*, No. 129016 (Oct. 31, 2022).
- 2. On December 28, 2022, the circuit court entered an opinion resolving plaintiffs' claims. The court held, among other things, that the provisions of the Act addressing pretrial detention are facially unconstitutional. Defendants-appellants appealed directly to this Court under Rule 302(a).
- 3. The parties subsequently filed an agreed motion to accelerate the docket under Rule 311(b), which this Court granted on January 5, 2023. The Court's order set out the following deadlines:

**Record on appeal:** Friday, January 20, 2023

**Defendants-appellants' opening brief:** Thursday, January 26, 2023

Plaintiffs-appellees' response brief: Friday, February 17, 2023

**Defendants-appellants' reply brief:** Monday, February 27, 2023

**Oral argument:** In the March 2023 calendar

- 4. The Clerk of the Circuit Court for the Twenty-First Judicial Circuit, in Kankakee County, which is responsible for preparing and certifying the record on appeal, see Ill. S. Ct. R. 324, today informed defendants-appellants that despite its diligent work to prepare the record on appeal, given the size of the record—which totals over 40,000 pages in 64 separate cases—it was not able to meet the January 20, 2023 deadline for the filing of the record on appeal, and will require two additional weeks, during the time when the parties' briefs are due, to prepare the entire record.
- 5. Given that the Court has ordered that this appeal be heard on an expedited basis, the parties and the clerk of the circuit court have conferred and obtained agreement on a proposal that will both accommodate the clerk's request for additional time and simultaneously allow the parties to meet their obligations under the Court's rules and the expedited scheduling order.
- 6. The parties anticipate that the record will be filed in two parts: (a) the record in the "lead" case, *Rowe v. Raoul*, No. 2022CH16 (Kankakee Cnty.), instanter; and (b) the record in the remaining, consolidated 63 cases on or before February 3, 2023. The parties thus respectfully request that the Court enter an order permitting the clerk to file the record in the lead case, *Rowe*, instanter. The parties agree that no other changes to the briefing schedule are needed.
- 7. This approach is justified for multiple reasons. As discussed, the record in these consolidated cases is lengthy—totaling over 40,000 pages—and the clerk has not been able to meet the deadline set on January 5 despite all possible diligence.

  The approach set out above will accommodate the clerk's request for additional time

while permitting the parties to meet their obligations under the January 5 scheduling order. That is so because the parties do not anticipate needing to cite any materials beyond the *Rowe* record, and thus can prepare and file their briefs before the Court, and meet the deadlines set on January 5, relying only on the initial tranche of the record on appeal.

8. All parties agree to the relief sought in this motion.

#### CONCLUSION

For these reasons, the Court should grant leave to file the record on appeal in the lead case,  $Rowe\ v.\ Raoul,$  No. 2022CH16 (Kankakee Cnty.), instanter.
